

# INSTRUCTION MANUAL

ensured that the fingers can be easily moved. The sizes of the gloves are marked in colour (refer to the colour of the sealing strap) and also with letters (refer to table) on the identity tag on the glove, as follows:

(br)own	(gr)een	(wh)ite	(r)ed	(b)lue	(or)ange
XXS	XS	S	M	L	XL

The gloves are available without and with sleeve extension. The correct glove is to be selected depending on the respective work intensity and safety level.

Safe closing of the glove is ensured via correct closing of the sealing strap and the press stud buckle. The overlapping ends of the sealing straps must be shortened, if these are longer than 25mm.

## Special Note Concerning Use of Protective gloves

The use of this protective glove is limited to using manual knives in the food, plastics, leather, paper and textile industries.

### Safety instructions:

The instructions for use must be read and observed prior to using the glove.

If you have any questions, contact your employer or the manufacturer.

The condition of the glove is to be checked prior to use each working day. In the case of defects such as deformed, defective or missing rings and/or to the sealing strap or the press stud buckle, the glove is to be presented to the employer and replaced.

The glove must not be altered or re-tailored by the user and is to be used in the design supplied.

The glove is electro-conductive and must not be worn near to open or unprotected lines.

The glove must not be worn on motorized vehicles or machines with moving parts.

The glove is not to be on the hand bearing the knife, but on the hand holding the product.

The user is responsible for checking article suitability for the respective purpose intended. Depending on the work involved, a glove with sleeve extension is optionally available to protect the upper or lower arm from cuts or stab injuries. Not suitable for handling hazardous materials.

### Selecting the gloves:

Before using the glove, the respective hand size must be established. The glove should fit well to the fingers and palm of the hand. In connection with the textile or plastic under-gloves, correct fitting must also be checked, and it must be

## Care/Cleaning:

To ensure ideal protection effect, the glove must be kept in perfect condition. The glove is subject to natural wear and tear in the case of normal use. If there are visible signs of wear such as deformed, defective or missing rings, worn sealing straps and/or press stud buckles, the glove must not be used and must be replaced.

Before or after cleaning, the glove must not be beaten or knocked on a hard surface.

The gloves must be cleaned and disinfected at least once a day using hot water, or in connection with a cleansing agent approved for the food industry. We recommend that the gloves also be brushed to remove any residue (eg. meat residue etc.). The gloves can also be cleaned in appropriate cleaning machines. The gloves are hung in appropriate cleaning boxes to ensure the

best possible cleaning effect.

With regard to cleaning, the user must comply with valid cleaning plans of the employer in order to ensure professional hygiene.

All the protective gloves production products are subjected to quality control of materials and the assembled product during production and prior to use. Defective goods are to be notified to the manufacturer pursuant to legal regulations. The manufacturer rejects any responsibility and liability claims, if the products have not been repaired and maintained in internal workshops. No guarantee or liability claims exist, if the products are not used properly and appropriately.
